26	CB comment		I am voting against the report writing document, because I think it is naive with respect to crime scene reconstructions facilitated or partially facilitated through bloodstain pattern interpretation. I urge members of the ASB to revisit this issue. I don't see how a "one size fits all" template can deal with the extreme variability and complexity of real-world crime scene reconstructions. It appears that only fairly simple examples involving the assignment of the causes of resulting patterns from a consideration the possible mechanisms producing them was being considered at the time this was approved. Crime scenes encountered in actual case work are commonly much more complex. In practice, rarely does the problem solution lie solely with monolithic blood deposit configuration considerations.
