This standard defines the minimum requirements to be met in a forensic DNA analyst training program for DNA reporting and review within the context of the laboratory's documented procedures. The aim is to provide a framework for quality training resulting in consistency within a laboratory and in the forensic DNA community.

- 3 This standard provides the requirements for forensic DNA laboratory's training program: 1)
- 4 preparing forensic DNA reports and/or notifications; and 2) performing technical and/or
- 5 administrative reviews on forensic DNA case records and reports.

- 14 administrative review
- An evaluation of the report and supporting documentation for consistency with laboratory policies
- and for editorial correctness.
- **17 3.2**
- 18 case record
- 19 The documentation of procedures, controls, and instruments used; observations made; results of
- tests performed; and charts, graphs, photographs, bench or other handwritten notes, and other
- documentation generated that are used to support the analyst's conclusions. May also be referred
- 22 to as "test record."
- 23 **3.3**
- 24 technical review
- 25 An evaluation of reports, notes, data, and other documents to ensure there is an appropriate and
- 26 sufficient basis for the scientific conclusions.

#### 27 4 Requirements

#### 28 **4.1 General**

- ANSI/ASB Standard 022, Standard for Forensic DNA Analysis Training Programs shall be used in
- 30 conjunction with this document because ANSI/ASB Standard 022 provides the foundational
- 31 training program requirements upon which additional specific requirements, such as this
- document, will be based.

- 33 The laboratory's training program shall include all requirements applicable to the work conducted
- 34 by the laboratory and by the individual in training.
- 35 4.2 Knowledge-based Training
- **4.2.1** At a minimum, the knowledge-based portion of the training program shall require review of
- 37 the following:
- 38 a) the laboratory's protocols for report writing;
- 39 b) the laboratory's protocols for case record review;
- 40 c) the laboratory's policies on confidentiality and disclosure of information;
- d) applicable literature as assigned by the trainer;
- e) literature on the effects of cognitive bias in decision-making processes associated with forensic DNA reporting and review.
- 44 **4.2.2** The knowledge-based training component of the laboratory's training program shall
- provide the trainee with basic instruction on report writing and review to include, at minimum, the
- 46 following topics.
- 47 a) Case Record Management
- 48 1) case record organization including order and pagination;
- 49 2) case record content.
- NOTE Examples include, but are not limited to, applicable processing worksheets (e.g., extraction,
- 51 quantification, capillary electrophoresis set-up worksheets), electropherograms, mixture deconvolution
- documentation, statistical records, table of results, and documentation requirements for interpretation (e.g.,
- stating assumptions of contributors) and conclusions.
- 54 b) Report Writing
- 55 1) template format including the subsections of the report and what is contained in each;
- 2) appropriately selecting reporting statements;
- 57 3) report issuance including policies on providing verbal results;
- 4) determining when the report is final;
- 5) issuance of amended reports.
- 60 c) Technical and Administrative Case Record and Report Review
- 1) use of quality control checks as required by laboratory protocols;
- 2) appropriate testing as defined by laboratory protocols;

- 3) criteria to be verified under the technical and administrative reviews;
- 4) laboratory protocol defining the order for each review;
- 65 5) what, if any, results can be provided prior to a released laboratory report;
- 66 documentation requirements for each review, including documentation of comments and corrections, and additional reviews after corrections are made;
- 7) qualification of personnel responsible for each review.

#### 69 4.3 Practical Training

- 70 **4.3.1** The practical component of the laboratory's training program shall provide the trainee with
- 71 practical instruction for the trainee to obtain the skills for report writing and review.
- 72 **4.3.2** At a minimum, the practical portion of the training program shall include the observation of
- a trained analyst performing report writing and review with DNA data and reports representative
- of those processed by the laboratory, at least once or until clearly understood.
- 75 **4.3.3** At a minimum, the practical exercises for report writing and reviews shall be representative
- of the range, type, and complexity of DNA data from routine casework or database samples, and
- data, case records, technologies, methodologies and platforms in accordance with the trainee's job
- 78 responsibilities and the extent to which the trainee participates in DNA data report writing and
- 79 review.

#### 80 4.4 Competency Component

#### 81 **4.4.1** General

- 82 The competency component of the laboratory's training program shall demonstrate knowledge-
- based and practical competency in report writing and review as used by the laboratory. The format
- of the test(s) and the criteria for passing the competency test(s) shall meet section 4.3 of ANSI/ASB
- 85 Standard 022 Standard for Forensic Training DNA Analysis Training Programs.

#### 86 4.4.2 Knowledge-based Competency

- As applicable to the trainee's job responsibilities, the trainee shall successfully complete (as defined
- 88 by the laboratory's policy) a knowledge-based test covering the critical information obtained
- during the training on case record management, forensic DNA report writing, and performing
- 90 technical and administrative reviews. The test(s) shall cover, at a minimum, the topics outlined in
- 91 4.2 and its subsections.

#### 92 4.4.3 Practical Competency

- The trainee shall successfully complete (as defined by the laboratory's policy) a practical
- competency test covering each of the forensic DNA reporting and review protocol(s) for which the
- trainee will be independently authorized to perform. DNA data from samples representative of the
- range, type, and complexity typically analyzed by the laboratory shall be included in the practical
- 97 competency test(s).

## Conformance

In order to demonstrate conformance with this standard, the laboratory shall meet the requirements outlined in Section 5 of ANSI/ASB Std 022, *Standard for Forensic DNA Analysis Training Programs* and all the requirements set forth in this document.
