Crime scenes can and have been compromised by first responders (however they be named) when they have failed to secure a scene and preserve evidence. Consequently, the first responders can either set the stage for a successful and thorough investigation or provide all the reasonable doubt fodder needed for a difficult presentation of the facts. Unequivocally this document needs to be a standard. The CSIR sub-committee of OSAC has identified the necessary actions for first responders, based on experience, and represents a sine quo non of what first responders need to do. The CSIR subcommittee of OSAC is concerned with the lack of communication between our task group and the ASB prior to this document being released for public comment. Substantial change were made to this document without any discussion or communication with the authoring OSAC subcommittee. The CSIR subcommittee thoroughly rejects the change of what was intended to be a standard into a best practice, especially in the absence of prior communication or rationale	Restore the document to a standard; restore all original "shall"s	Reject: There is no doubt that the success of any forensic investigation begins with the response by first responders. I believe the focus of the ASB is to create standards for forensic service providers while providing best practices guidance for those individuals (law enforcement, fire, and EMS). First responders in most instances are faced with numerous issues when responding to a scene. Many of those issues are directly related to personal safety and in averting personal injuries to responders.

Treating a scene as a crime scene affords the most narrow perspective and the highest level of prudence in matters of evidence preservation, identification, documentation, collection and interpretation. Treating a suspicious scene as a crime scene sets the tone for the best level of investigation, and should the matter under consideration be deemed non-criminal, it is easier and preferable to de-escalate the investigation.	Restore the original wording and placement. Furthermore, it would serve the intent of the document better by restoring the original note after 3.8 (definition of "scene")	Reject with modification: Note added back to definition of "scene" (3.7). "Perimeters" is the term currently used in Forensic Science text books, so it is appropriate to keep it consistent with current text terminology.
