The technical review is designed to ensure the correct application of the methodology and the appropriateness of the reported information. This review offers an opportunity to ensure there is appropriate and sufficient support for the actions, results, opinions, and interpretations which may have occurred during the analysis or in the generation of the report. In addition, the technical review provides a means of reassurance and confidence to its stakeholders that quality measures have been followed.



- **4.1** Forensic Science Service Providers shall establish written policies and procedures for
- technical review of reports that are prepared in accordance with the ANSI/ASB Standard 031,
- 36 Standard for Report Writing in Bloodstain Pattern Analysis.
- 37 **4.2** The technical review shall be performed by a second bloodstain pattern analyst.
- 38 5 Technical Review Process
- 39 **5.1 General**
- 40 **5.1.1** The technical <u>reviewer</u> review shall be objective.
- 41 **5.1.2** After review of reviewing the data and evidence supporting documentation the technical
- reviewer should be made aware of what questions the report author was asked to evaluate.
- 43 5.2 Evaluation and Supporting Documentation
- 44 **5.2.1** The technical reviewer shall evaluate supporting documentation prior to reviewing the
- 45 author's report.
- 46 **5.2.2** Documentation of the items and evidence reviewed provided for review shall be included in
- 47 the case folder. file. Deviations from this process shall be documented.
- 48 **5.2.3** Supporting documentation to be provided to the technical reviewer should include, but is
- 49 not limited to, the following.
- 50 a) Photographic images.
- b) Autopsy and medical reports and images.
- 52 c) Forensic biology reports.
- d) Crime scene diagrams.
- 64 e) Analysis notes.
- f) Any other documents referenced in the report as used for achieving final interpretations and
- 56 opinion.
- 57 5.3 Review of Analyst Report
- 58 **5.3.1** The report shall cover all examinations, documentation, and observations supporting the
- analyst's opinions and conclusions.
- 60 **5.3.2** Any amendments made to the report as a result of the technical review shall be documented
- and addressed by the reporting analyst.
- 62 <u>5.4</u> Deviations from this process shall be documented.

- 64 **6.1** Attempts shall be made to resolve disagreement(s) that occur during the review process.
- 65 **6.2** If a disagreement occurs regarding observations/classification of a bloodstain pattern, the
- resolution shall be to report the classification that results in an(s) where there is agreement shall
- 67 <u>be reported</u>.
- EXAMPLE A disagreement between the classification of a pattern as an expiration pattern vs. an
- impact pattern might result in the classification being reported as spatter stains.
- EXAMPLE A disagreement between the classification of a pattern as an impact pattern vs.
- spatter stains might result in the classification being reported as spatter stains.
- 72 **6.3** If a disagreement occurs over an interpretation or opinion, the resolution shall be to report
- the most specific case interpretation or opinion on which both the analyst and the reviewer agree.
- EXAMPLE A disagreement in a case interpretation between whether a victim was kneeling or
- upright during an impact bloodshed event might result in the reporting of the height of the
- impact pattern alone with no further interpretation.
- 77 **6.4** If the analyst and technical reviewer cannot agree, another qualified bloodstain pattern
- analyst shall be consulted to assist in resolving the disagreement. The consultation shall be
- documented in the case file.
- 80 6.5 Prior to the release of the report all disagreements between the analyst and the technical
- 81 reviewer shall be resolved.
- 82 7 Documentation of the Technical Review
- 7.1 The technical review shall be documented and maintained in the case record of the
- 84 analystfile.
- 85 **7.2** The documentation in the case recordfile shall include, but is not limited to the following:
- a) Any changes made during the technical review process.
- b) any resolution of conflict;
- 88 c) signature (or electronic equivalent) of the reviewer(s);
- d) date(s) of review;
- 90 7.3 Confirmation that a technical review has been completed shall be included in the reporting
- 91 analyst's case file.
