<b>1-Mar</b>	Submission of Application for Accreditation	<b>\$1,500 non-refundable</b>
<b>1-Mar to 15-Apr</b>	Review of applications by Commission and decision on eligibility	
<b>16-April</b>	Program notified of acceptance or rejection of application; begins work on Self-Study Report	
<b>30-Jun</b>	Program submits first version of Self-Study Report to FEPAC	<b>\$2,500</b>
<b>July</b>	Commission selects on-site review teams	
<b>1-Jul to 1-Aug</b>	Two Commission members review each Self-Study	
<b>1-Aug</b>	Comments from Commission review returned to Program	
<b>15-Aug</b>	Program submits final version of Self-Study Report to FEPAC	
<b>1-Aug to 15-Aug</b>	Program works with FEPAC Accreditation & Outreach Manager and Site Team leader to schedule on-site visit	
<b>15-Sep to 15-Oct</b>	On-Site Evaluation visits	<b>*US programs \$2,950 + \$1,475</b>
<b>15-Oct to 14-Nov</b>	Each Self-Study, including on-site team comments, is reviewed by two Commission members	
<b>1-Nov</b>	Program submits Annual Report	
<b>15-Nov</b>	Program receives Self-Study with evaluation team comments and Commissioner comments	
<b>1-Dec</b>	Program submits payment for Annual Maintenance Dues	<b>\$1,750 (additional \$500 for each FEPAC accredited concentration)</b>
<b>1-Dec</b>	Start date of new Application submissions for next calendar year	
<b>1-Dec</b>	Program responds to review comments	
<b>January</b>	Commission conference call to discuss reports and vote if no additional information is required	
<b>February</b>	Commission meets at AAFS Meeting to vote on accreditation or give final approval for January votes	
<b>February (post AAFS conference)</b>	Program receives notification of voting result – 10 days after completion of AAFS Annual Conference	

On-Site evaluations within the contiguous US are charged \$2,950. If the program has multiple programs or concentrations being reviewed at the same time, an additional \$1,475 per on-site evaluator will be charged if additional reviewers are required. Programs outside the contiguous US will be charged actual expenses.
